Paulding County Boy Kidnapped

(Paulding County, GA) At approximately 0557 hours on 07/30/15 Deputies responded to 91 Lake Swan Court Hiram, GA 30141 in reference to a possible kidnapping. Upon arrival they discovered that the victim, William Dorian Moxley, was last seen at the residence between 11:00 pm – 12:00 am. They also learned that a live-in houseguest was also missing from the residence along with the family car. Timothy Lee Wilson AKA “Lee Jacks”, who was living with the family, was last seen on 07/29/15 between 11:00 pm – 12:00 am also.

Initially, we do not have any reason to believe that Wilson would harm Moxley. However, we are treating this very seriously because Wilson did not have permission to take Moxley anywhere combined with the fact that he has an extensive criminal history. We are not certain where Wilson may be going, but think he possibly could be headed toward Winchester, Tennessee (Franklin County) because that is where his family resides.

Victim:

William Dorian Moxley: W/M, 12 YOA, 5’00” tall, 100lbs., dark hair. Moxley was last seen wearing a green *Minecraft* shirt and blue shorts with black and silver *Airwalk* shoes.

Suspect:

Timothy Lee Wilson AKA “Lee Jacks”: W/M, 33 YOA. Jacks has tattoos and was last seen wearing plaid shorts with blue strings.

Vehicle Description:

2007 white Chevrolet Cobalt LS 4 door bearing Georgia tag PZH 9125

At approximately 11:00 am on 07/30/15 an alert Georgia State Patrol Trooper spotted the suspect vehicle on the Georgia stretch of Interstate 24 in Dade County. Rather than stopping the vehicle and risk getting a pursuit started, the seasoned Trooper waited for backup to arrive. Once Tennessee Highway Patrol Troopers arrived, they initiated a traffic stop at Exit 155 just off of Interstate 24. Georgia and Tennessee Troopers were able to safely stop the suspect vehicle and recover the child. Dorian is reported to be in good condition and Detectives responded to Tennessee to speak with Wilson and to pick up Dorian Moxley to bring him home.

The Paulding County Sheriff's Office would like to thank the Federal Bureau of Investigation, the Georgia Bureau of Investigation, the United States Marshal's Service, the Georgia State Patrol, and the Tennessee Highway Patrol for the assistance they provided in bringing this case to a peaceful resolution. Sheriff Gary Gulledge stated, "Without the assistance of the aforementioned agencies, this case could have ended with a tragic result. I want to send my most sincere thanks to everyone that helped get Dorian Moxley safely back home".
